### 3.. Report By Road Repair Committee

1. **Speed bumps**: A long discussion about speed bumps wanting to be placed on Cowboy Trail along with a petition was presented to the board regarding placement of speed bumps. The residence along Cowboy trail and other areas raised concerns regarding the speed of cars, some are residents, some are UPS, FedEx, Trash trucks and construction workers. It was mentioned that speed bumps are shown not to slow down traffic, dips have more effective results on slowing traffic and Botz, the dots in the road. It was also mentioned to put up a pronghorn sign, warning drivers to be aware. Some people have almost been hit

by speeding traffic in this community. Another suggestion was residents can place a speed bump on the effective street, although many did not want to pay and there can be a liability.

- ✓ Sheriff's department will be contacted.
- ✓ It is important that residents talk with the neighbor who is speeding on the street, contact the UPS, FedEx, Trash companies and contactors if they catch them speeding.
- ✓ Also, if you see a suspicious car which is parked along the roadside, call the Sheriffs department right away. They will come out the take care of it.
- ✓ UPDATE: I spoke with the Sheriff's Department, and they state that because we are private roads, they don't patrol them. They will try to have a traffic enforcement on Outer Loop and hopefully this will stop speeding in our area. When we mentioned that won't stop the speeding in our community, they stated we needed to contact County Road department and have them grade the rate of speeds our roads would be. There will be a very large fee. We asked them to please come to our next board meeting March 6<sup>th</sup> and they stated they will look into it but could not give me an answer. They also asked to have a copy of the petition. The copy of the petition was given to the substation on Outer Loop, along with the photo of the car parked in November.
- 2. **Road repairs:** Williamson Valley Ranch Road and Cowboy Trails are roads that need repair. The Road committee will present their findings at the March meeting.

### **Legal Aspects of Deadly Force:**

- **AZ Murder**: ARS 13-1105: Taking another person's life by means of a premeditated and intentional act. A violation of this law is a Class 1 felony punishable by death or life imprisonment.
- CA Murder: CPC 187: The unlawful taking of the life of a person or fetus with malice aforethought.
- **Justifiable Homicide:** Justifiable homicide, or excusable homicide, is a type of defense used in criminal law where in certain circumstances the homicide of another if there is sufficient evidence to prove that it was reasonable to believe that the offending party was under imminent threat of death.
  - See 13-411. <u>Justification</u>; use of force in crime prevention: A person is justified in threatening or using both physical force and deadly physical force against another if and to the extent the person reasonably believes that physical force or deadly physical force is about to happen.
  - o There is no duty to retreat before threatening or using physical force or deadly physical force.
  - Reasonable belief vs. Bare Fear

#### • Brandishing vs. Defensive Display:

o ARS 13-421. <u>Justification</u>; <u>defensive display of a firearm</u>; <u>definition</u>: The defensive display of a firearm by a person against another is justified when and to the extent a reasonable person would believe that physical force is immediately necessary to protect himself against the use or attempted use of unlawful physical force or deadly physical force.

Lethal Force Justification: "I was afraid of death or great bodily injury for myself or another."
