Mark Lienau, President called the meeting to order at 7:00 p.m.

**Attendees:** Mark & Sara Lienau, Sharon & Hoppy Hopkins, Debra & Len Dodwell, Jan Macis, & Linda & David Brubaker.

**Secretary:** The minutes from the November 9<sup>th</sup> meeting were read. Approval was made after the addition of the candidate's name, Georgine Lockwood.

**President's Report:** Mark found out that ADOT adds glass beads to the yellow line paint on the roads when the paint is still wet to make the lines show up at night. Debra found out that Grady's will redo the areas we have already done, correctly, for \$400. The board voted to do it. Debra will contact Grady's.

The ditch work for the 3 property owners has been partially completed. One owner did his own and the next door property owners. The third owner has elected not to do his, instead, he has asked up to do it and bill him. Jan was asked to called VH Grading and make the arrangements. Jan said there is a problem with the berms as described; these berms need to be at least 2 to 2 ½ feet high. Jan asked for the contact numbers of the 2 owners whose trenching was complete so that she can discuss the berm height. Sara will supply.

The area behind Tom Boelts house is still an issue. Mark just needs time to meet with Tom to discuss this.

The weeds on Corriente Circle still need to be taken care of. Sharon reported that Chino Rentals has a 500 gallon tank with a pump available for rent for \$60 a day. Everyone seems uncomfortable about burning because of the large amount of brush. Jan mentioned that since VH will be here, how about asking them to take care of it? We all agreed that this would be good. The brush can either be moved to a flat open site or burned, or they can be buried.
